



# ***Welcome to the Bridger-Teton National Forest***

*We hope that your visit to the Jackson Ranger District is a pleasant one. For a safe and enjoyable visit, please practice the responsibilities associated with use:*

1. All MOTOR VEHICLE USE MUST OCCUR ON DESIGNATED ROUTES shown on the Motor Vehicle Use Map. Motorized travel off designated routes is not permitted except to access dispersed campsites located within 300 feet of a designated road. The Map displays what routes are open to motor vehicle use, when routes are open, and what class of vehicle is permitted (full-size vehicles, ATVs, or motorcycles). Maps are available on the BTNF website. Your cooperation will help protect road and trail surfaces, reduce resource impacts, and retain the abundance and diversity of wildlife Jackson Hole is known for. (CFR 261.13) (\$225)
2. GRIZZLY AND BLACK BEAR ACTIVITY has increased in this area. Special food storage regulations are in effect and apply to much of the Bridger-Teton National Forest (all of Buffalo Ranger District and all of Jackson Ranger District except for Willow Creek area ½ mile south of the Hoback River). In the interest of safety for people and bears, keep a clean camp and keep attractants unavailable to bears (see info on back). (CFR 261.58(cc)) (\$175)
3. BE EXTRA CAREFUL WITH CAMP FIRES. Choose an established site with a pre-existing fire ring. Never leave your fire unattended. Completely extinguish your fire at night and before you leave camp. Have plenty of water available to put out your fire. If there is any heat, your fire is not out and may ignite again in the afternoon heat (see info on back). (CFR 261.5(d)) (\$225)
4. PACK OUT YOUR TRASH. All garbage and refuse must be packed out. Glass or metal does not burn in campfires – pack it out. (CFR 261.11(b)) (\$125)
5. PREVENT WATER POLLUTION. Latrines for human waste must be dug at least 100 feet from water sources. Leaving exposed human waste and toilet paper is unsanitary and ruins the experience for others. (CFR 261.11(b)) (\$150)
6. CAMPING LENGTH OF STAY IS LIMITED. The maximum length of occupancy at any site is five days in most areas of the Jackson Ranger District from May 1 – Labor Day. Camping is prohibited in the Snake River corridor (except in developed campgrounds) and in areas near the towns of Jackson and Wilson. After 5 days, a minimum of 30 days is required before returning to another campsite on the District. This regulation is meant to give everyone an opportunity to use the area. (CFR 261.58(a)) (\$125)
7. The State of Wyoming requires an OFF-ROAD VEHICLE PERMIT to use roads and trails enrolled in the State ORV program. The permit is a sticker which must be visibly displayed on the left hand side of your ATV or motorcycle. These permits can be obtained from many vendors in the Jackson and Moran area. All funding goes back into trail maintenance and education programs to benefit ORV riders. (CFR 261.15(i)) (\$100)
8. To prevent the spread of weeds, only CERTIFIED WEED-FREE HAY is permitted on the National Forest. Since weed seeds can be caught in tire treads, picked up in mud, or become temporarily lodged on the underside of vehicles, we recommend thoroughly washing your vehicle before you enter the Forest and after you leave. (CFR 261.58(t)) (\$75)

# CAMPFIRE REGULATIONS Don't Risk starting a Forest Fire !



## **PUT IT DEAD OUT!**

1. **Add water**
2. **Stir it up**
3. **Touch it**

### **3 second rule-**

*if you can't hold your hand in the fire's ash for longer than 3 seconds... **it's not out!***



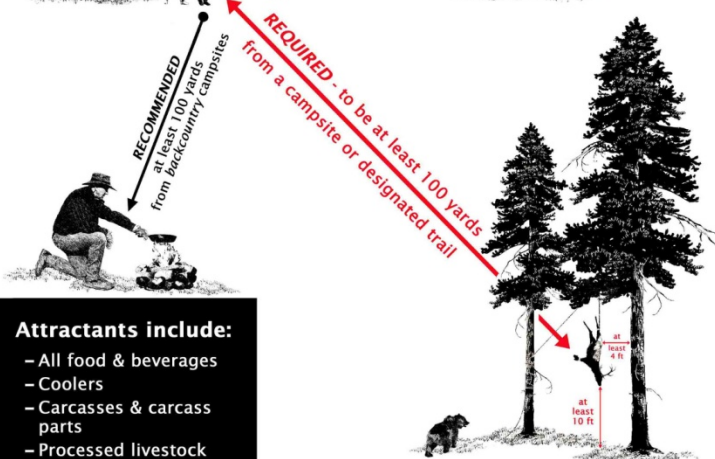
## Food Storage Regulations

Keep a Clean Camp

Coolers are NOT bear-resistant

Proper storage of food, refuse and other attractants means:

- in a hard-sided vehicle, or
- in a *certified* food storage container, or
- as shown below:



### Attractants include:

- All food & beverages
- Coolers
- Carcasses & carcass parts
- Processed livestock feed and grain
- Toiletries & cosmetics
- Cooking grease
- Garbage

Carcasses left on ground are **REQUIRED** to be:  
- at least 1/2 mile from any campsite, **and**  
- at least 200 yards from any designated trail

All Attractants must be **unavailable** to bears at night and during the day when camp is unattended. Attended means that a person is physically present within 100 feet and in direct sight of the food or carcass.

Violations of the Food Storage Order are punishable by a fine of not more than \$5000 or imprisonment for not more than six months, or both (16 U.S.C. 551, and 18 U.S.C. 3559 and 3571). In effect March 1 - December 1.
